User of this pass must agree to follow the rules for use established by Palm Island Transit, Inc. This pass is property of Palm Island Transit, Inc. as such Palm Island Transit Inc. has the right to revoke and/or confiscate this pass at any time. Non-refundable. Abuse of any kind toward Palm Island Transit employees will not be tolerated and are grounds for revoking pass.
